MOTION TO AMEND THE NOTICE OF APPEAL

Counsel for Terrance Wing respectfully requests to amend the Notice of Appeal in the above-captioned case. In support of this request, counsel shows:


1. Appellant filed his Notice of Appeal *pro se* on April 18, 2024. The Initial Brief of Appellant was filed on June 26, 2025, and the Initial Brief of Respondent was filed on December 15, 2025. The Record on Appeal and a proposed transportation order were filed on January 14, 2026. This Court issued the exhibit transportation order on January 16, 2026.

2. After receiving the order, the Beaufort County Clerk of Court notified opposing counsel that there was a typo on the indictment numbers, which correctly read 2020-GS-07-02234, but incorrectly read 2020-GS-07-02293 instead of -02292, that were listed on the transportation order. The typo that appeared on the transportation order was obtained from the Notice of Appeal.

3. Undersigned counsel respectfully requests to amend the Notice of Appeal and otherwise asks this Court to update its records to reflect a change in the indictment numbers from 2020-GS-07-02234 and 2020-GS-07-02293 to 2020-GS-07-02234 and 2020-GS-07-02292. The indictment ending in -02293 belongs to another defendant and is unrelated to this appeal. The correct indictment number ends in -02292.

WHEREFORE, the undersigned counsel would respectfully request to amend the Notice of Appeal to reflect the correct indictment numbers. Counsel would also request that this Court update its records to reflect the correct indictment number and issue an amended exhibit transportation order.


