**APPELLANT'S FOURTH MOTION FOR EXTENSION OF TIME TO FILE AND
SERVE THE RECORD ON APPEAL**

Appellant Bundy McDonald, LLC (“Appellant”), pursuant to Rule 240(a), SCACR, respectfully requests an extension of time of fourteen (14) days within which to file and serve the record on appeal in the above referenced Appeal.

This is Appellant’s FOURTH motion requesting an extension of time to file and serve the record on appeal. **However, the third motion only included a request for fourteen (14) days rather than the full thirty (30) days.**
