

Hello my name is Mr. Evarald Grant SCDC # 00399784. I recieved a letter from William G Yarborough III who was my attorney representing me on my case in Greenville county... His address is 308 W. Stone Ave Greenville SC 29609. He stated that he filed a motion for my appeal. The Appellate case # is 2026-000091. I first want to explain that i'm not from South Carolina let alone i'm not even from America. I'm 38 years old i'm originally from Kingston Jamaica I was born there.. I moved to Englewood California in 2015 I was 27 years old at the time.. I am married in America I have two beautiful daughters one is 8 years old and the other is 9 years old.. I met my wife which already had 4 kids which were two boys and two girls ages are 21 years old, 19 years old, 16 years old, and 13 years old.. I have been in their life for years I took them in as they were mine.. Once again i'm from Jamaica I have a great heart I was poor I came from nothing so my love is pure I believe in happiness and peace.. I was charged in Greenville S.C with a Trafficking 1st offense.. I never ever have been in any trouble prior to this I have no kind of record or anything.. I have family in Greenville S.C I flew out on a plane from California to visit.. I was caught with two keys of cocaine.. I was in Greenville a couple months and I was in need of some things and my pride would not let me ask my family.. I was stealing packages from people addresses not knowing I would end up stealing a package with cocaine on the inside of it.. I feel like the truth would be better for me I been telling the truth to my attorney's the whole time.. I feel like nobody was on my side, I started my case with a paid attorney named Brian Faller from Greenville S.C I told him the absolute truth about everything and he just took my money and used it for me to assign him to me and he worked completely against me.. He did not believe anything I told him and I paid him my money so I fired him... I explained to him I was stealing packages how was I suppose to know what was inside them.. I never expected to steal a package with cocaine in it and the police was waiting on someone to get the package whether it was me or someone else but they were already in place that day to catch someone sadly it was me that happened to get the absolutely wrong package.. I fired him and I hired another attorney by the name of Bakari Sellers of Columbia SC. I paid him to represent me he did the exact thing the first lawyer did he was working with the police he tried to get me to tell him something I didn't know.. I told him I was stealing packages so how was I to know who the package belonged to or where it came from.. Now with him I spoke to the Solicitor by the name of Grace Hunington from the 13th Circuit.. I spoke with her and the arresting officer from Greenville County who is the Drug enforcer by the name of Mr. Morgan. They agreed to drop the charges and make it a lesser charge to plea to.. I asked Bakari Sellers to take me up for a bond and he would not take me up for one he said I couldn't get a Bond. I then fired him because he was not helping me at my best interest he used me for my money.. I'm not from America they tricked me they know I don't know anything about the law they was telling me anything to get my money. I then hired Mr. William G Yarborough III Esquire of Greenville S.C. He was taking me up for a bond and I got denied.. Then he took me to court in the Blind I didn't even know I was going to court. He came to me with a plea for 15 to 20 years telling me that if I didn't take it I would go to trial and get 25 to 30 years I was in shock because I didn't know what was going on.. I was scared for my life so I rushed into the plea deal. I pleaded to 15 to 20 years for the sake of my life. The Judge gave me 21 years on a Trafficking 1st. I got more than I pleaded to. Once again I have no prior record or anything I'm a family man these people took me from my kids. I was treated very unfair on a 1st offense I was used for my money I have no clue about anything with SC Law period. They knew I didn't know anything and they used it against me. I'm not even American how am I suppose to understand something if nobody telling me what I need to know.. I feel like I deserve a second chance in court I need ^{from} someone who is going to help me the right way.. I have the money to assign the person I need assigned to help me.. They know that and that's why they been taking all the advantage of me they could because I don't know anything.. I don't know the law and they took my money and they screwed me. I mean for crying out loud my 1st offense I was sentenced to 21 years that's insane.. I have kids that need me

I would love to see them and spend time with them.. I feel so incomplete without my family.. Please let me come back to court and give it another shot with another attorney. I feel I deserve a better sentencing or atleast another chance to have my freedom.. I've been a man and accepted the fact that I was wrong but I feel I was treated very unfair in this case.. I feel that the solicitor wanted to set a example out of me and for what reason I don't know. My wife is frustrated without me, I mean I don't even sale drugs I'm a family man.. If I could come back on this appeal I would really appreciate it. How could I plea to something less and recieve something more than I pleaded to. The attorney's I paid just plain out used me for my money.. It even states it in the bible that you are not to trust a lawyer and a Judge and etc. It's all apart of a game they play and I got played because im not American and im dumbfounded of the law, what good is paying money and still failing when im paying a lawyer for help I don't understand.. I'm currently looking into another attorney so if it's possible could I please Appeal my case thank you.... Once again im MR. Everald Grant SCDC # 00399784 . I'm currently being housed at Columbia prison Kirkland Institution in R+E.. I don't have the guts to do 21 years I can't even take doing another day here.. I'm strassing very bad I'm barely eating and im praying non-stop.. I pray that I get back in court and overturn this case enough to free me or atleast free me soon.. Please see where im coming from and feel my pain please I wanna go home, I wish I never came to South Carolina I've never been in Jail at all before in my life im 38 years old I wanna go home i'll do whatever it takes please.... I'm filing this letter to appeal my case I pray this letter is accepted..
