Freddie Williams, appeals the conviction and sentence in this case. The sentence was imposed by the Honorable David Caraker, on January 29, 2026.

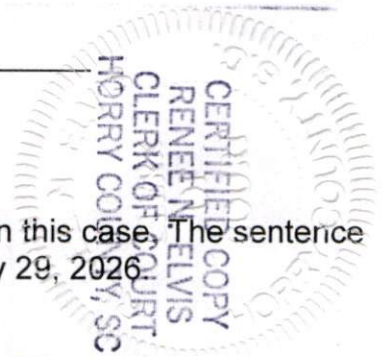

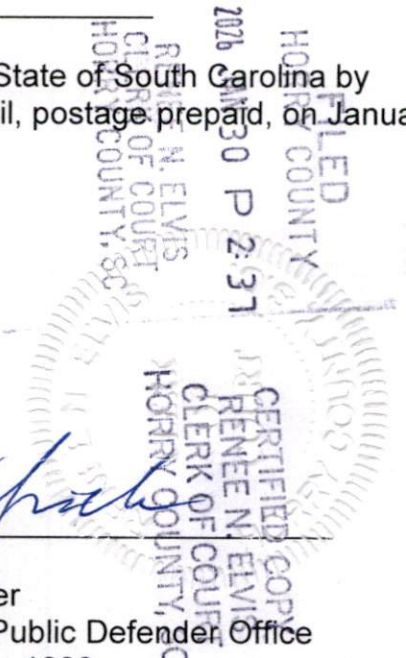
