MOTION FOR EXTENSION OF TIME FOR APPELLANT TO SERVE AND FILE
INITIAL BRIEF AND DESIGNATION OF MATTERS TO BE
INCLUDED IN THE RECORD ON APPEAL

Pursuant to Rule 240, SCACR, Pro Se Appellant respectfully moves for an extension of the time in which to serve and file Appellant's Initial Brief and Designation of Matters to be included in the Record on Appeal. This is Appellant's first request for an extension of time.

The grounds for the motion are as follows:

1)The Order was received on December 12, 2025. The Notice of Appeal was filed on December 22, 2025 in the Court of Common Pleas in Saluda County and in this Court.

2)Two transcripts were ordered and received. The latter of the two was received on January 29, 2025 after Appellant did a search for the transcript from November 20, 2025 upon Notification of Overdue Letter.

3) Transcriptionist attempted to CC Appellant on January 7, 2026, with a copy of the transcript but for some unknown reason, the transcript did not arrive into the designated mailbox of Appellant. If Appellant had received this transcript the Appellant's Initial Brief and Designation of Matters to be included in the Record on Appeal would be due on February 6, 2026.




