Per your text, letter dated 01/21/2026, the undersigned Pro Se Appellant' health, unfavorable monthly test results are causing her to cease her argument in the above case. Subsequently, avoiding continual stress and not being able to afford an attorney.

I tried and did the best I could being unfamiliar with the appeal process. However, the following facts remain.

1. Respondent was initially paid in 11/2016 to build a room to my existing home with a written contract. 2. He was paid a second payment in 02/2017 to complete work. 3. Respondent chose to stop work in 05/2017 before completion breaking contract. 4. Appellant filed a complaint in 07/2017 with the SCLLR Board.
5. In 02/2018 after onsite investigation, this Board sanctioned, fined him for ABANDONMENT, WORKING OUTSIDE HIS SCOPE, LYING ON AC BUILDING and CODES APPLICATION.
6. Case was heard in AC Summary Court twice with Judge William 'Dan' Sharp. Dismissing case due to 3 year Statute of Limitation had expired, secondly saying he could not tell which party was being truthful.
7. Case was heard in Appellate Court twice.
8. Appellate Judge Perry Gravely's Order dated 12/01/2023 remanded case back to Summary Court due to no contract existed. 9. Appellate Judge S/R Lawton McIntosh's Order dated 12/28/2023 dismissed case due to my being a Pro Se litigant which initiated this appeal.
10. Carolyn Galloway, Respondent's former lover, per his talking in 01/2017, has been the attorney in all hearings. 10. These facts were told to all 3 judges in each hearing.

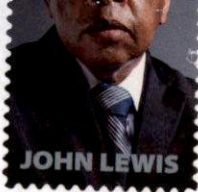
