To whom it may concern, My name is Tanya Murphy. Ms. Murphy would like to give a brief on why this case was appealed. Ms. Murphy asked Judge Mc Kinnon to recuse himself before the appeal hearing because he may be biased or have a conflict of interest from two other high profile cases that he may have had ties to. Thank you for contacting the United States Postal Service. This is in response to your inquiry regarding your certified mail with Tracking Number 9589 0710 8270 0604 3599 45.

Best way to go

Certified Mail service does not provide for a detailed accounting of the movements of the mail as it travels through the system. Certified Mail provides a receipt to the mailer at the point of mailing and, upon receipt at the office of the addressee, we retain a delivery record. It is dispatched and handled in transit as ordinary mail with no definitive tracking capability. Consequently, it is generally not possible to trace a single piece of certified mail when customers report it missing.

In addition, there are some businesses that receive thousands of letters each day, many sent by mailers who want to have a record of delivery. The Postal Service delivers this type of accountable mail in bulk to each agency's mailroom. Each piece is recorded on a computerized list by article number. When the mail is turned over to the agency, mailroom personnel verify the numbers for each item against the numbers on the computerized list. Mailroom employees then sign the list, verifying delivery, before distributing the mail to offices within the agency. Certified Mail signature proof of delivery is not automatically provided unless Return Receipt service is purchased.

There are times, when the mail piece is delivered; however, we fail to properly scan the mailpiece as being delivered. Certified items are sometimes missed when the trays and tubs of mail are being checked prior to the business picking up their mail. If there is no delivery scan on your mailpiece, it does not necessarily indicate the item was not delivered.

In these instances, we recommend that customers contact the business to inquire whether the mailpiece was delivered. We regret such oversights, realize the inconvenience, and worry it can cause our customers. I assure the failure to scan your item properly has been addressed with the appropriate management.

Although I cannot erase the disappointment this service failure has caused you, you are entitled to the refund of the cost to certify the mailpiece. Please take your original mailing receipt to your local post office for a refund.

Please accept our apologies for failing to provide the service you paid for and for any inconvenience this matter has caused you.

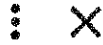
