The notice filed with the appellate court shall be accompanied by the following:

- i. Notice of Appeal (attached Form 1 in Appendix C to Part II)
- ii. Proof of service showing that the notice has been served on all respondents (attached Form 7 in Appendix C to Part II)
- iii. A copy of the order(s) and judgment(s) to be challenged on appeal if they have been reduced to writing
- iv. A filing fee as set by order of the Supreme Court: \$250.00

\*\* Please note: if you are filing a motion with your notice of appeal, an additional \$50 is required.
