PETITIONERS’ UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE REPLY

Petitioners CDM Corporation, Inc. and Guardian Fiduciary Services, LLC, respectfully move this Court for a 10-day extension of time to file their reply brief. Respondent does not oppose this requested extension.

In support of this motion, Petitioners state as follows:

1. On November 18, 2025, this Court granted certiorari to the Court of Appeals of *South Carolina Board of Financial Institutions v. CDM Corporation, Inc. and Guardian Fiduciary Services, LLC*, Appellate Case No. 2023-000017 (S.C. Ct. App. filed May 28, 2025).
2. On December 18, 2025, Petitioners filed their opening brief, along with the appendix.
3. By extension, on February 9, 2026, Respondent filed its brief.
4. Petitioners’ Reply is due to be filed on or before February 19, 2026.
5. Due to other case-related obligations, Petitioners request an extension of 10 days to file their Reply.

6. If the Court grants this request, the Reply will be due on March 2, 2026.

7. This is the first request for an extension by Petitioners to this Court, and the time herein is within the 20-day cumulative maximum amount of time allowable for extensions under Supreme Court Order 2014-07-16-01.

8. This request is made in good faith, not for the purpose of delay, and neither Petitioners nor Respondent will be prejudiced by this extension.

9. Counsel for Petitioners have consulted with counsel for Respondent, and the undersigned is authorized to state that Respondent does not oppose this request.

Counsel for Petitioners therefore respectfully request the Court grant this motion and extend the time for filing Petitioners' Reply until March 2, 2026.
