MOTION FOR AN EXTENSION TO SERVE AND FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Tyrone L. Robinson respectfully requests a **final thirty (30) day extension, from February 17, 2026 until March 19, 2026** in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Tyrone L. Robinson respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Petition for Writ of Certiorari to the Court of Appeals and accompanying appendix in the case of The State v. Marcus D. Batson with the Supreme Court on February 3, 2026. Counsel filed the Brief of Respondent in the case of The State v. Quinterris J. Carmichael with the Supreme Court on January 28, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of George R. Dreher v. State with the Supreme Court on January 21, 2026. Counsel filed the Petition for Rehearing in the case of The State v. Terrence O. Frazier with the Court of Appeals on January 7, 2026. Counsel filed the *Anders* Brief of Appellant and Record on Appeal in the case of The State v. Jacob R. Mims with the Court of Appeals on January 6, 2026. Counsel filed the Petition for Rehearing in the case of The State v. Manly M. Thompson with the Court of Appeals on December 18, 2025. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Amy Wright v. State with the Supreme Court on December 15, 2025.


4. Counsel makes this request in good faith and not for purpose of delay.

5. On February 3, 2026, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through March 1, 2026.
