
NOTICE OF APPEAL

Ivan Moore appeals the January 29, 2026, Appellate Panel Decision and Order of the South Carolina Worker's Compensation Commission. On January 29, 2026, Appellant received a copy of the Appellate Panel Decision and Order.

As required by S.C. Code Ann. § 42-17-60, the grounds for appeal and the alleged errors of law are:

1. The Commission erred as a matter of law in admitting the deposition testimony of Dr. Hoenig.
2. The Commission erred in affirming the Single Commissioner's decision that Claimant's total left knee replacement is not causally related to his March 1, 2016, work injury because that decision is not supported by substantial evidence and record as a whole.


