MOTION FOR AN EXTENSION TO SERVE AND FILE  
THE PETITION FOR WRIT OF CERTIORARI  
AND APPENDIX

Counsel for Larry Durant respectfully requests a **final thirty (30) day extension, from February 20, 2026 until March 23, 2026**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Larry Durant respectfully submits that extraordinary circumstances

Counsel filed the Petition for Writ of Certiorari to the Court of Appeals and the Appendix in the case of The State v. Rodney David Riggins with this Court on January 27, 2026. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals and the Appendix in the case of The State v. William Lee Roseboro, Jr. with this Court on January 27, 2026. Counsel filed the Brief of Respondent in the case of The State v. Samir Kevin Shank with this Court on January 20, 2026. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Dale E. King v. The State with this Court on January 20, 2026. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v Carlton Devonte Brown with the Court of Appeals on January 7, 2026. Counsel filed the Petition for Rehearing in the case of The State v. Celia Windham with the

Court of Appeals on January 7, 2026.


4. Counsel makes this request in good faith and not for purpose of delay.

5. On February 3, 2026, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through March 1, 2026.

WHEREFORE, the undersigned counsel would respectfully request a **final thirty (30) day extension from February 20, 2026 until March 23, 2026**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the Petition for Writ of Certiorari and Appendix be held in abeyance pending a ruling on this motion.
