OF RESPONDENT/APPELLANT STEPHEN D. LAW, D.O.**


Respondent/Appellant Sean D. Fay, as Personal Representative for the Estate of

Respondent/Appellant Stephen W. Law, D.O., for an order reinstating his appeal in this
matter. Respondent/Appellant Fay agrees with the position that the appeal Dr. Law filed
should not have been dismissed. Furthermore, the cross-appeal filed by Fay also should

not have been dismissed. The only portion of this matter that should have been dismissed was the appeal by Grand Strand Regional Medical Center, LLC.


