




Please find enclosed for filing with the Court appellant's Notice of Appeal and Proof of Service for the above captioned case. The \$250 filing fee is enclosed.

By copy of this letter, I have this date served copies of these documents on The Honorable Ralph K. Anderson, III, Chief Judge of the S.C. Administrative Law Court, and Lake E. Summers, Esquire, counsel of record for Respondent S.C. Department of Corrections.

Concerning the Court's order of February 3, 2026, the Court granted the request to hold briefing timelines in abeyance until any related appeals have been filed, and the parties shall provide the Court with a status update every 60 days. With this appeal, all appeals have now been filed: 26 cases in the December 9, 2025 Brannon appeal; and 141 cases in the 3 appeals filed today (139 in Ackerman order, 1 in Kelly order, and 1 in Wright order). There were 30 cases not appealed for various reasons. In light of the Court's February 3 order, please advise if the initial brief is due within 30 days, or additional time will be allowed because of the consolidated order. Finally, since all cases have now been appealed, I assume this satisfies the Court's request for a status update every 60 days.
