



At a Court of General Sessions, convened on the 14th day of October, 2022, the Grand Jurors of Laurens County present upon their oath:

The defendant, Bryan Preston Cooper, did in Laurens County, on or about October 18, 2020, knowingly, willfully and unlawfully oppose Ryan Parham while serving, executing, or attempting to serve or execute a legal writ or process or did resist an arrest being made by Ryan Parham with the Laurens County Sheriff's Department whom he knew or reasonably should have known was a law enforcement officer, all in violation of Section 16-9-320(A), Code of Laws of South Carolina (1976, as amended).
