did within this county and state on or about 3/9/2025 violate the criminal laws of the

State of South Carolina (or ordinance of County/ Municipality of Colleton)

in the following particulars:

DESCRIPTION OF OFFENSE: Drugs / Trafficking in meth. or cocaine base - 28 g or more, but less than 100 g - 1st offense

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on March 8th, 2025, at approximately 2041 hours I, Deputy Smith, conducted a traffic stop on a Dodge truck bearing SC tag X623250 operating on Cooler Dairy Road near Sawmill Road, displaying a blue light on the exterior of the vehicle, within Colleton County. The defendant/driver and sole occupant was identified as David Michael Delong. Sgt. Scott deployed his K9 (Deuce) to conduct a free air sniff, which alerted to the presence of possible illegal substance. A probable cause search was conducted and Deputy Smith found 2 clear bag containing a crystal substance between the driver seat and center console. The defendant made the excited utterance to Deputies where the substance was located. The substance field tested positive for methamphetamines and weighed 46.31 grams. This act was done in violation of Title 44, Chapter 53, Section 375 of the South Carolina Code of Laws, 1976 as amended. OCA # 25-00748

At a Court of General Sessions, convened on May 15, 2025, the Grand Jurors of Colleton County present upon their oath:

Trafficking Methamphetamine More Than 28 Grams But Less Than 100 Grams - 3rd/subsequent offense

That in Colleton County, South Carolina, on or about March 8, 2025, the Defendant, David Michael Delong, did knowingly sell, manufacture, deliver, purchase, or otherwise bring into this State, or provide financial assistance or otherwise aid, abet, attempt, or conspire to sell, manufacture, deliver, purchase, or bring into this State, or was knowingly in actual or constructive possession of more than twenty-eight grams but less than one hundred grams of methamphetamine or cocaine base as defined and otherwise limited in Section 44-53-110, 44-53-210(d)(1) or 44-53-210(d)(2) and David Michael Delong had been previously convicted of two or more violations of a controlled substance offense provision, other than a marijuana offense provision, of Article 3, Narcotics and Controlled Substances, or of another state or federal statute relating to narcotic drugs, depressants, stimulants, or hallucinogenic drugs, and one of those previous violations was within ten years of a first violation of a controlled substance provision, other than a marijuana offense provision, of this Article or of another state or federal statute relating to narcotic drugs, depressants, stimulants, or hallucinogenic drugs, to wit: Defendant was convicted of Trafficking Methamphetamine on December 6, 2016 in Volusia County, Florida and Defendant was convicted of Trafficking Methamphetamine on May 23, 2018 in Volusia County, Florida, all in violation of Section 44-53-375(C)(2)(c), 44-53-470(A)(3), 44-53-470(A)(4), et al. of the Codes of Law of South Carolina.
