Chief Justice Toal,

I am writing this letter in regards to the ORDER you did on October 3, 2012 concerning Appellate Case No. 2010-154481. In the Order you denied that Counsel be relieved as Counsel and ordered that Petitioner file a petition within (30) thirty days of order. Counsel complied, not to my Satisfaction, however a brief was done and filed on November 2nd of 2012. You also ordered that Respondent shall have thirty days thereafter to serve and file its return. Chief Justice Toal, Respondent "has never" complied with your ORDER and this isn't right. If Petitioner does not comply within the Chief Justice ORDER he waives his right to the Courts.
