Well I'm in need of this Legal mail And Don't need (Stg) if (Security Threat group) or Classified as that within this SCDC Corporation this is (Some New) In House Bogus Memorandum) they've put out in SCDC to have our legal mail looked at so they can Block us and deny us Legal Envelopes and Counter Act us trying to contact the courts, I was Just Threatened on 11-21-13 By Deputy warden Davis (over smu) at Lee C.I. If I keep complaining to the courts about my mail and other things Held personally Have me thrown in (Supermax) were there's worser conditions and very cold at for No Reason Just a form of Retaliation. This threat has me feeling my lifes in Danger here on smu around him he and other supervis - ors have started telling people Pby with my mail and (Deny me Access to Legal materials).
