**RESPONDENT'S OPPOSITION TO APPELLANT'S JANUARY 9, 2026 MOTION FOR
EXTENSION OF TIME AND RESPONDENT'S MOTION TO DISMISS**

Respondent South Carolina Department of Transportation ("Respondent" or "SCDOT") hereby opposes, by and through its undersigned counsel, Appellant's Motion for Extension of Time. Further, Respondent hereby moves for an Order dismissing the Appellant's Notice of Appeal.

WHEREAS Appellant filed Notices of Appeal¹ on or around September 10, 2025 appealing Judge Hyman's Order denying Landowner/Appellant's Motion for New Trial;

WHEREAS, by correspondence dated September 12, 2025, Appellant's then counsel, Desa Ballard, Esq., indicated that a copy of the transcript for this appeal was received on

September 12, 2025 and calculated an Initial Brief of Appellant and Designation of Matter deadline of October 13, 2025;

WHEREAS Appellant's Counsel of Record filed a Motion to Be Relieved as Counsel on or around September 12, 2025, and was so relieved by Court Order on or around October 9, 2025;

WHEREAS, pursuant to the October 9, 2025 Order, this appeal was held in abeyance for 30 days to allow Appellant an opportunity to obtain new counsel;

WHEREAS, on or around November 10, 2025, Appellant filed a Motion for Extension of Time for 60 days, indicating that Appellant was seeking new counsel and that "additional time [was] necessary to allow the new attorney adequate opportunity to review the record and prepare the required filings;"

WHEREAS, by Court Order dated November 19, 2025, this appeal continued to be held in abeyance for an additional 60 days from November 19, 2025;²

WHEREAS on or around January 9, 2026, Appellant filed a second Motion for Extension of Time; significantly, Appellant's January 9, 2026 Motion failed to include a new reason as to why the Court should grant the Appellant additional time to serve and file its Initial Brief of Appellant and Designation of Matter;

WHEREAS the Appellant has failed to establish an extraordinary circumstance for which this Court should grant a second extension of time;

WHEREAS the Court has not issued an Order granting or denying Appellant's January 9, 2026 Motion for Extension of Time; however, Appellant still has not filed its Initial Brief of Appellant and Designation of Matter;

² "If an attorney licensed to practice law has not made an appearance on behalf of the appellant within sixty (60) days, this Court will presume the appellant to be proceeding pro se. *No further extensions will be granted absent extraordinary circumstances*" (emphasis added).

WHEREAS, as of the date of this Motion, the original deadline for the Initial Brief of Appellant and Designation of Matter was almost five (5) months ago; furthermore, the extension this Court did grant by its November 19, 2025 Order lapsed over a month ago and Appellant has not been granted an additional extension;

For the reasons herein, Respondent respectfully requests an Order from this Court denying Appellant's January 9, 2026 Motion for Extension of Time and dismissing Appellant's appeal with prejudice for failure to progress this appeal.


