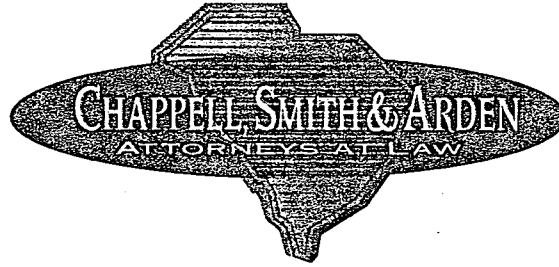

Please accept this letter as a formal request for submission of the case on the Briefs and Record.


