MOTION FOR AN EXTENSION OF TIME
TO FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Tarell Richardson respectfully requests an extension of thirty (30) days from March 11, 2026 until April 10, 2026 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Tarell Richardson respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Return to the Petition for Rehearing in the case of The State v. Eric A. Graham with the Court of Appeals on February 9, 2026. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Mercury L. Williamson with the Court of Appeals on February 6, 2026. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals and accompanying appendix in the case of The State v. Marcus D. Batson with the Supreme Court on February 3, 2026. Counsel filed the Brief of Respondent in the case of The State v. Quinterris J. Carmichael with the Supreme Court on January 28, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of George R. Dreher v. State with the Supreme Court on January 21, 2026. Counsel filed the Petition for Rehearing in the case of The State v. Terrence O. Frazier with the Court of Appeals on January 7, 2026.

4. Counsel makes this request in good faith and not for purpose of delay.


