

Pursuant to SCRCRCP Rule 25(a)(1) "if a party dies and the claim is not thereby extinguished...[a] motion for substitution may be made by any party or by the successors or representatives of the deceased party and together with the notice of hearing shall be served on the parties as provided in Rule 5 and upon persons not parties in the manner provided by Rule 4 for the service of summons. If substitution is not made within a reasonable time, the action may be dismissed as to the deceased party".

Since Respondent George D. White was the original instigator in this case, who started the false allegations and with those allegations the whole of the case begin to roll against the Appellant, George D. White was the lead Defendant/Respondent in this case.

Therefore, and pursuant to SCRCRCP Rule 25, Appellant Motions to this honorable Court to substitute George D. White to The Estate of George D. White and have all references to George D. White removed as motioned and replaced with the said The Estate of George D. White.

This substitution motion is also filed in pursuant to SCRCRCP Rule 25(e) Substitution at Any Stage.




