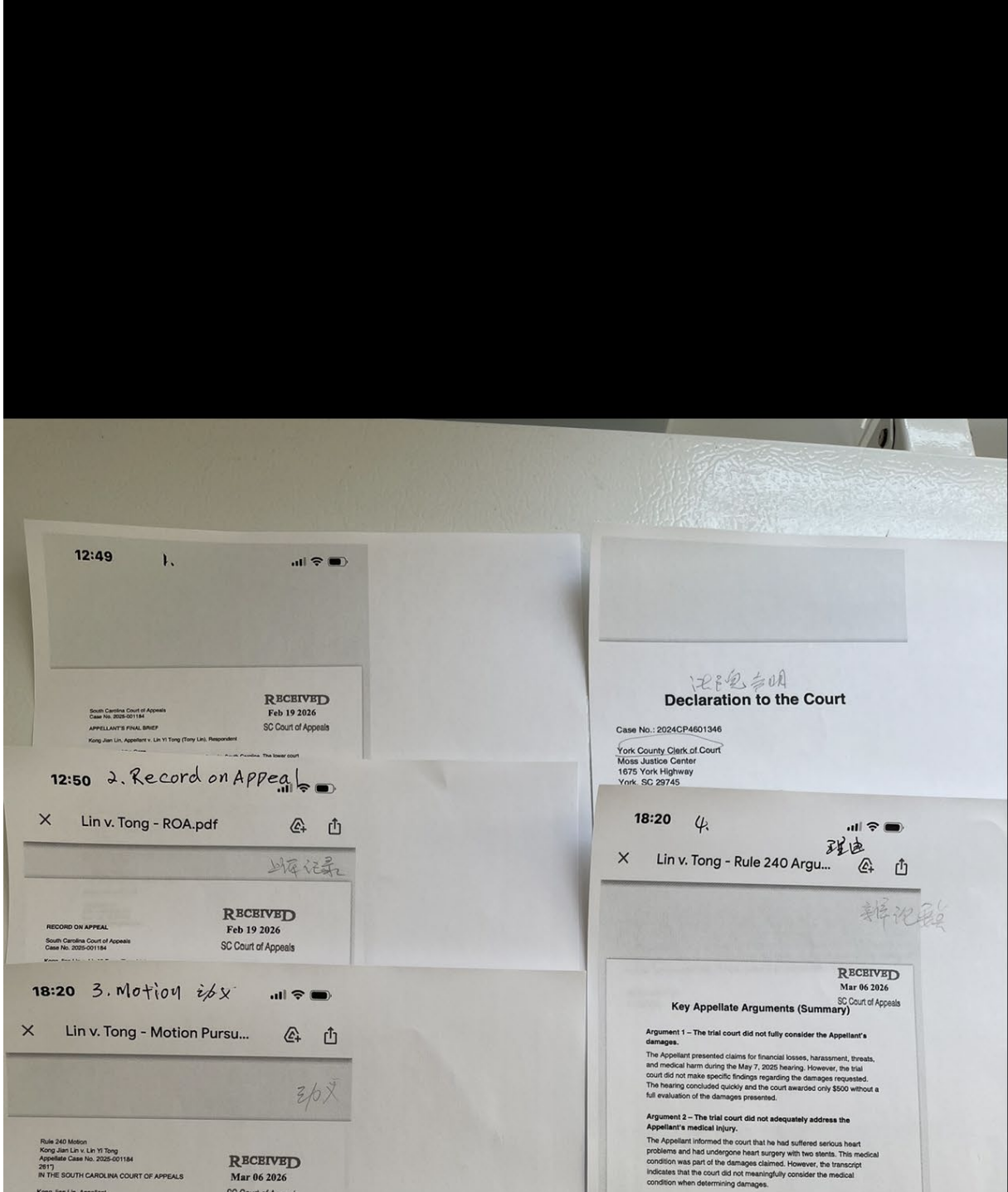

### MOTION PURSUANT TO RULE 240, SCACR  
Appellant, Kong Jian Lin, respectfully submits this motion pursuant to Rule 240, SCACR, requesting the Court to consider the following matters related to the record and proceedings in the trial court.  
1. During the hearing held on May 7, 2025, the Appellant presented claims for damages, including financial losses and other harm caused by the Respondent. However, the trial court did not address or make specific findings regarding the amount of damages requested by the Appellant.  
2. The Appellant also informed the court that he had suffered serious heart problems and underwent heart surgery with two stents placed in his heart. This medical condition and its impact were presented to the court as part of the damages suffered by the Appellant. However, the hearing concluded without the court addressing or evaluating this issue.  
3. The hearing lasted only a short period of time, and the Appellant believes that important aspects of his claims, including the damages and medical harm he suffered, were not fully considered before the court issued its ruling.  
4. The Appellant respectfully requests that this Court consider these circumstances when reviewing the case on appeal.  
WHEREFORE, the Appellant respectfully submits this motion pursuant to Rule 240, SCACR, and requests that the Court take these matters into consideration in its review of this appeal.
