**PETITION FOR REHEARING / MOTION TO RECONSIDER  
DISMISSAL ORDER OF MARCH 11, 2026**

To the Honorable Clerk of the South Carolina Court of Appeals:

Appellant Jesús Concepción respectfully petitions this Court to reconsider and reverse the Order of Dismissal entered on March 11, 2026, dismissing the appeal for failure to pay the filing fee required by Rule 203, SCACR.

Appellant mailed the filing fee in the amount of \$250.00 on January 16, 2026, to the Clerk of the South Carolina Court of Appeals at Post Office Box 11629, Columbia, South Carolina 29211. The payment was sent by money order and was intended to satisfy the filing fee in this appeal.

Appellant has supporting evidence showing that the payment was prepared and sent on January 16, 2026. On that same date, Appellant sent notice by email to Sarah Anderson Timmons, Esquire, advising that the payment had been mailed. The email included the same cover letter that was sent with the money order.

Attached as supporting exhibits are: (1) a copy or photo of the money order receipt; (2) a copy of the January 16, 2026 cover letter sent with the filing fee; (3) the January 16, 2026 email notice to Sarah Anderson Timmons, Esquire, advising that the payment had been sent; and (4) the January 16, 2026 transaction history showing Food Lion money order purchase and USPS payment.

Appellant respectfully submits that these documents support that the filing fee was timely mailed and that the dismissal should therefore be reconsidered. In the alternative, if the Court did not receive the filing fee, Appellant respectfully requests leave to promptly re-submit the filing fee so that the appeal may proceed on the merits.

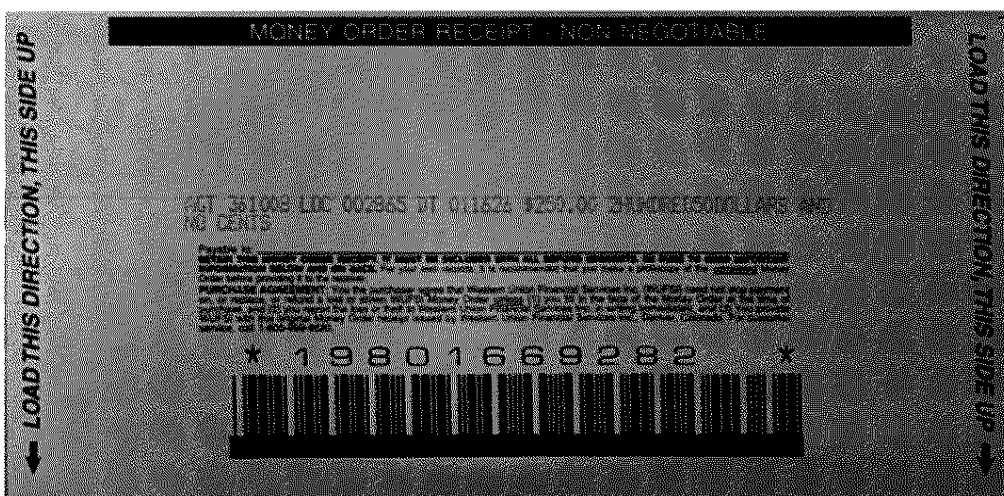
