ASSOCIATES, ASC, LLC'S SECOND MOTION FOR EXTENSION TO FILE
THE INITIAL BRIEF AND DESIGNATION OF MATTER**

Pursuant to Rule 263, SCACR, Appellant Carolina Orthopaedic and Neurosurgical Associates, ASC, LLC (CONA ASC, LLC), by and through its undersigned counsel, respectfully requests a 30-day extension of the March 27, 2026 deadline to file its initial brief and designation of matter.
