MOTION FOR EXTENSION OF TIME**

Pursuant to South Carolina Appellate Court Rules 240 and 263(b), Appellant-Respondent Rom Reddy moves for an extension of thirty (30) days from the existing deadline of March 30, 2026 to file his Initial Brief and Designation of Matter to be Included in the Record on Appeal.
