**MOTION FOR EXTENSION OF TIME  
TO FILE APPELLANT'S BRIEF**

Appellant, Nikia Renee Noisette, appearing in propria persona sui juris, respectfully moves this Honorable Court for an extension of time to file the Appellant's Brief, and in support thereof states as follows:


1. Appellant's Brief is currently due on March 20, 2026.
2. Appellant respectfully requests an extension of fourteen (14) days, or such other time as this Court deems just and proper.
3. Good cause exists for this request. Appellant experienced a sickle cell crisis requiring emergency medical treatment, including treatment in the emergency room on March 10, 2026.
4. Appellant was also required to travel to Duke University Hospital on March 13, 2026, after being approved for Lyfgenia, a stem cell therapy treatment for sickle cell disease, which required further medical evaluation, consultation, and follow-up.
5. These medical circumstances have significantly limited Appellant's ability to

complete the appellate brief within the current deadline.

6. In support of this motion, Appellant attaches medical documentation, including the emergency room note and Duke University Hospital visit documentation, as Exhibit A and Exhibit B.
7. This request is made in good faith and not for purposes of delay, but to allow Appellant a fair opportunity to adequately prepare and submit the brief.

WHEREFORE, Appellant respectfully requests that this Court grant an extension of fourteen (14) days, or such other period as the Court finds appropriate, to file the Appellant's Brief.



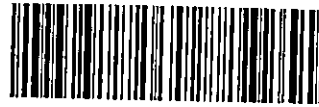
