I'M TRYING TO APPEAL MY CAUSE, ALSO

THEN, BUT HERE IT COME, I FILED A FEDERAL LAWSUIT
AGAINST THEM, IT'S GOING TO BE HEARD SOON, END OF
DISCOVERY IS MARCH 30TH 2026. THE U.S. COURT AGREES
WITH ME, BUT I WAS GIVEN ONLY 12 HRS NOTICE FOR
COURT, HADN'T EVEN MADE A FIRST APPEARANCE, I WAS IN
CHESTERFIELD COUNTY JAIL FROM 4-17-25 - UNTIL 12-9-25

UNDER A RIDICULOUS BOND, I'M 66 YEARS OLD, I BEEN
OUT ABOUT (6) WEEKS, XMAS, NEW YEARS, SNOW, ICE, SNOW,
ALL THE WAY UP TILL 2-3-26, MY LAWYER DID NOT DO
NOTHING, IF YOU LISTEN TO HIM ON THE BAIL HEARING
TRANSCRIPT ON 12-8-25, LOOK AT ALL THE DEFENSES, THEN
(THEY DIDN'T HAVE A SEARCH WARRANT AND SNEAKED UP AND
SHOT EXPLODING CERNADES INTO MY RESIDENCE) LOOK AT
THE TRANSCRIPTS FROM 2-3-26, THE JUDGE GRANTED
ME UNTIL FRIDAY FEB 6TH 2025, I SAID WITH ALL THIS
HAPPENING I WAS NOT ABLE TO MAKE A DECISION, I WAS
MENTAL UNSTABLE, I WAS IN JAIL FOR 9 MONTHS, I BEGGED
THEM (NURSE) TO LET ME GO TO MENTAL HEALTH, NOT (1)
TIME, I TOLD JUDGE I NEED MORE TIME, LITTLE DID I KNOW
MY HIRED ATTORNEY MR. ARTHUR AIKEN SOLD ME OUT, AND
YOU KNOW WHY, JUDGE CALLED AIKEN, SPANNA CAMPBELL
IN HER CHAMBERS, AND I ASK WHAT'S GOING ON, AND
HE ADMITTED IT HE SAID JUDGE McCASKIN HE KNOWN
30 YEAR, SHE TOLD HIM, "STAND DOWN" ON THIS CASE
OR YOU GONE REGRET IT, CAUSE I DO ALOT OF CASES
ON THIS CIRCUIT, AND SHE TOLD AIKEN, I WILL MAKE
IT HARD ON EVERY CASE OF YOURS I DO, AND IT BLOWED
MY MIND, I TOLD HIM BEFORE WE GOT THE COURT
THAT DAY, I NEED TO GO TO MENTAL HEALTH, THIS TOO
MUCH ON (1) OLD MAN, SO AFTER THE JUDGE GAVE ME

THOSE (3) DAYS UNTIL FRIDAY Feb 6TH, I went to my
doctors APPT I HAD SCHEDULED AND SHE RIGHT AWAY
SENT ME TO MENTAL HEALTH. SHE AND MY WIFE ARE
FRIENDS, BEEN WITH HER ALONG TIME, I WAS IN MENTAL
HEALTH ALL DAY THURSDAY (5TH) AND FRIDAY 6TH BUT
I GOT (1) PHONE CALL AND ON THE 5TH I CALLED
THE ONLY NUMBER I COULD REMEMBER, THE LADY
AT THE CHESTERFIELD COUNTY SHERIFF'S DEPT,
MRS. PAT KELLY, SHE EVEN TOLD THEM I CALLED
HER TO TELL THEM TO RESCHEDULE ME, MY SISTER-
-IN-LAW LISA RODRIGUEZ CALLED ATTORNEY ARTHUR ALLEN
HOURS BEFORE COURT AND TOLD HIM, HE SAID HE
WOULD HANDLE IT, WHAT MORE CAN I DO, DOCTORS
SAID I WAS CHRONICALLY, PHYSICALLY AND EMOTIONALLY
ON THE EDGE, I HAD TO STAY WITH LISA UNTIL
MONDAY Feb 9TH 2026, BACK TO THE HOSPITAL MY
~~DOCTOR~~ DOCTOR SAID, THIS TIME ANOTHER HOSPITAL, POLICE
OF PAGERLAND, S.C. TALKED TO ME, SAID THEY ALSO
KNEW MY WIFE, MR BOOR WE GOT AN AMBULANCE
ON THE WAY, I GUESS I SHOULD TELL YOU MY WIFE
IS A VIETNAM ERA, HONORABLE, SERVICE CONNECTED
VETERAN 69 YEARS, THE FUNERAL HERE WAS SUPPOSED
TO SHIP HER BACK TO HER HOMETOWN TO BE BURIED
IN A NATIONAL MEMORIAL (BIRMINGHAM MISS.) WITH HER

BROTHER (MARINE) AND EVENTUALLY ME; SHE'S A NATIONAL HERO, AND THEY'VE GONE TO DO THIS, ANYWAY, AND SOMEBODY TELL ME, WOULD YOU NEED MENTAL HEALTH AFTER THIS, ANYWAY THE HOSPITAL ON THE 9TH Feb, CAROLINA PINES IN WAREHOUSING S.C. RELEASED ME TO MY DAUGHTER AND SON-IN-LAW IN PATRIOT, TOLD ME IF THE FACILITIES DON'T CALL YOU IN 7-10 DAYS FOR A BED TO COME OPEN, CALL US AND YOUR DOCTOR BACK, BUT AFTER 8 DAYS HERE COME THE SHERIFF'S DEPUTIES RUN UP IN THE HOUSE, DRAG ME TO JAIL, PUT ME IN A DARK SECLUDED CELL FOR 6 DAYS AND SHIPPED ME TO PRISON. I SIGNED NOTHING, ARTHUR AIKEN DOES NOTHING IN COURT, HE DIDN'T COME SHOW UP, LOOK AT THE TRANSCRIPTS I GUESS, TRANSCRIPTS

I BEEN TRYING TO WITHDRAW MY PLEA THAT I NEVER AGREED TO, AND NOW LOOK AT HOW FAST THEY RUN ME THROUGH THEIR LITTLE GRUNTLES, NOW THEY TRYING TO KEEP ME FROM APPEAL AND I WANT AN APPEAL, EVERYTHING I'VE DONE SO IN MY REQUEST SUCH AS (WITHDRAW PLEA) APPEAL HAS BEEN TIMELY, THEY KNOW WHAT THEY DID, I GOT WITNESSES TO THAT WAS IN THE COURT ROOM, I'VE ALSO WROTE TO COUNSEL ON INDIANAPOLIS OFFICE, (2) TIME, BUT THEY ARE TRYING TO MESS ME UP. IN OR NUMEROUS MEDICATIONS, I WAS STARTING TO DO
A LITTLE BETTER AT MY DAUGHTERS, BUT HERE THEY
COME, TALKING ABOUT I'M A FUGITIVE, ARE THEY ON
DRUGS, ALL I CAN DO IS TELL YOU GUYS, I NEED
AN APPEAL ATTORNEY, CAUSE I'M BROKE, MY FAMILY
GOT THE MONEY FOR ARTHUR AIKEN, NOW THEY CAN'T
AFFORD IT, BUT THEY STILL HAVE MY WIFE'S REMAINS
AND WON'T GIVE THEM TO ME.
