

Dear Ms. Ivey:

This is to acknowledge that on November 2, 2013, I received your transcript request for the afore-mentioned proceeding. I have reviewed my records and estimate that the transcript invoice will be approximately \$260.00 (\$3.25/pg). The State charges \$35.00 in addition for E-mail transcripts. I can return any extra monies as described below.

Rule 607 provides that the rate of \$3.25 for an original (or .75 for a copy) shall be charged per page for a transcript. Anything requested expedited is charged pursuant to State guidelines, and I can furnish that information if you decide to order the transcript expedited. Upon receipt of your deposit funds, I will be able to place your request in line for production. If the transcript cost is less, I will refund the difference to you upon delivery of the transcript. If the transcript cost is more, the balance will be due prior to delivery of the transcript.

Under our Rules, I have 60 days in which to complete the transcript after the receipt of your deposit. In addition, I am allowed to request from Court Administration 30-day extensions, if necessary, to complete the transcript. You will be notified if extensions are granted. If you desire to cancel your request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.
