


MOTION FOR COSTS



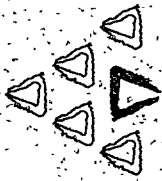
