I am responding to your letter of March 13, 2026. Our firm represents KDP II, LLC, in these appeals. I have conferred with the attorneys for the other parties who have approved this letter.

In response to your inquiry, the parties to this appeal are parties to an unsigned settlement agreement, which was submitted on March 2, 2026, to the State Fiscal Accountability Authority for consideration and approval. The proposed settlement agreement includes several other parties and is subject to a number of contingencies including approval of the settlement by the State Fiscal Accountability Authority and an appropriation of the State's contribution to the settlement amount by the General Assembly this legislative session. We should know by June if these two contingencies will be met. The methodology of setting and the location of the jurisdictional lines are not addressed in the settlement.
