Dear Ms. Howard:

As you may be aware, seven (7) of the Respondents filed a total of six (6) Briefs in response to the initial Brief of Petitioner Builders FirstSource–Southeast Group, LLC (“BFS”). While many of the Respondents’ arguments and underlying issues are similar, many are not, which is why six (6) separate Briefs were filed by the Respondents. In response to the five (5) questions pending review before this Court:

1. Respondents East Coast Carpentry and Palmetto Trim and Renovation filed a joint Brief setting forth seventeen (17) separately captioned arguments;
2. Respondent ECC Contracting, LLC’s Brief sets forth twenty (20) separately captioned arguments;
3. Respondent AC Construction, Inc.’s Brief sets forth sixteen (16) separately captioned arguments;
4. Respondent Pohlman Quality Exteriors Inc.’s Brief sets forth three (3) separately captioned arguments;
5. Respondent Hurley Services, LLC’s Brief sets forth seven (7) separately captioned arguments;
6. Respondent WS Contractors, LLC’s Brief sets forth three (3) separately captioned arguments.

Due to the number of arguments and issues raised by the Respondents, I respectfully request an extension of forty-five (45) days to prepare and file BFS’s Reply Briefs. Prior to filing this Motion, I sought and received consent from all of the Respondents’ counsel to the forty-five (45) day extension. Currently, BFS’s Reply Briefs to East Coast Carpentry/Palmetto Trim and ECC Contracting are due on Friday March 27, 2026 and

BFS's Reply Briefs to AC Construction, Pohlman Quality Exteriors, Hurley Services, and WS Contractors are due on Monday March 30, 2026. If granted, I believe BFS's Reply Briefs to East Coast Carpentry and Palmetto Trim and ECC Contracting would be due on or before May 12, 2026, and BFS's Reply Briefs to AC Construction, Pohlman Quality Exteriors, Hurley Services, and WS Contractors would be due on or before May 15, 2026.

Enclosed with the hard copy of this correspondence is the required \$50.00 filing fee.
