Complaint and Argument

To this Appeal's Court please review all documents in my transcript because they detail and support this Appeal. They will show why I should be granted a Full Summon (Restraining Order for Harassment and Stalking). (See attached Transcript)

(1) Honorable Judge Adonikam J. Hudson should be reprimanded for misusing his power in the Magistrate Court. He allowed people with Mr. Dixon to make statements to him during the hearing without being on the witness stand and being sworn in. Judge Hudson said that Mr. Dixon would have to have harassed and stalked me three (3) times before I can get a restraining order. However, that was a false and untrue statement. Because of Judge Hudson's actions in this court, I feel that he should be publicly reprimanded by this court for giving fraudulent statements to keep me from getting a fair hearing. Judge Hudson treated me unfair at the hearing by telling me he would put me in jail for 30 days if I said anything while Mr. Dixon was talking, therefore meaning I couldn't object to anything he said that was not true while he was talking. Judge Hudson lied to me by saying the hearing was not recorded and that I couldn't get the name of Mr. Dixon's witness who testified in his defense. He also would not let me completely cross examine Mr. Dixon's witness. I have medical records to support that I am afraid for my life and I am taking medication for PTSD.

(2) I feel that the Honorable William H. Seals, Jr. did not review the facts in this case that I gave the court in my defense in reference to Mr. Dixon's harassment and stalking me whenever he might want to and there won't be anything that I can do to defend myself. I am a Vietnam Vet and I am seeing a therapist for PTSD Anxiety/Depression for Mr. Dixon's action. I am afraid to go out during the day and at night in case I might encounter Mr. Dixon. I am a minister and I have to speak and travel to many places in the surrounding areas Timmonsville, Florence, Marion, Darlington, Dillon and other surrounding towns for events. I am afraid that if I run into Mr. Dixon he would take action against me for him losing his job at Harris Teeter for his violation of the company's policy for his action against me. This was caught on Harris Teeter's camera and the witnesses that were in line. (See Police Report)
