





That in Orangeburg County, South Carolina, on or about December 25, 2024, the Defendant, Jasmin Lynne Dubose, did, as part of a mob and without color or authority of law, for the premeditated purpose and with the premeditated intent of committing an act of violence upon the person of another, inflict an act of violence upon the body of [REDACTED] which resulted in bodily injury to [REDACTED] all in violation of Section 16-3-210(D), et al. of the Codes of Law of South Carolina.

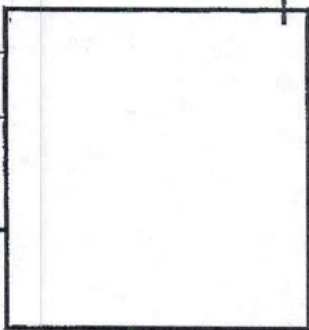
