Dear Ms. Kitchings and Amelia:

Due to the size and nature of this Appeal, our Record on Appeal will more than likely exceed 2,000 pages. As required by Rule 210 of the South Carolina Appellate Court Rules, we are obligated to file fifteen (15) copies with the Clerk.
