The Court's Judgment and Order signed by the Court on November 18, 2013 and entered on November 19, 2013. See Ex. A attached hereto.



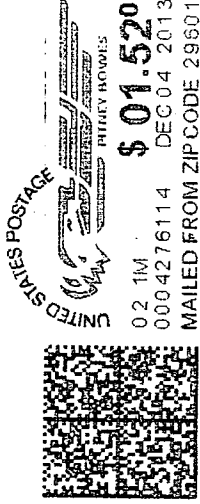
