Appeal to South Carolina Supreme Court 03/28/2026 Edit

I, Ken Moorehead appeal this action to the SC supreme court for the main issues in this case on law are that I was deprived my right to due process of law or a trial. The main issues are as follows:

1. I lost my entire life without a trial and think that I should be allowed to stay with the monitor on and not be put back in jail but should be entitled to a trial by an impartial jury even know I took the plea bargain or an Alford Plea.
2. The plea is different than Alford plea it is not that I thought had no chance winning the trial or being found innocent or proving facts it was unnecessary suffering or cruelty of being held for twenty-six months in J Reuben detention center. I did not want to be further victimized as in the past harassed, intimidated or held hostage anymore especially when public defender Scott Grau stein stated to me in 08/2025, I be there a year or more without a trial and could be longer. I was also told I would NOT be allowed to come back to court for few a month if I did not take the plea in 08/2025.
3. I still sent an appeal on time filed or sent a plea to SC court on appeal by jail mail in 08/2025 before I was released after the Alford plea and record shows I sent appeals to SC court of appeals and the rehearing's as the SC supreme court requested. I also think or tried to file the appeal as per 203 and the appeal was excepted
4. The main issue here is that someone should be able to have trial when the speedy trial act or Amendment six is claimed as in 10/2023 and as pleadings show I repeatedly claimed rights on the records filed in Conway Criminal court.
5. The trial or due process or speedy trial is unjustly denied after twenty-six months when claimed by a person in any state INCLUDING BUT NOT LIMITED TO SC in, many cities or states these rights have been upheld and the courts had trials before this time SC should NOT BE above this standard OR SHOULD GIVE A TRIAL BEFORE THIS TIME
6. I think twenty-six months is absolutely to long for anyone including economic deprived persons who earned way below standards to be denied a trial or due process.
7. The other issue of United States code 42 section 1983 deprivation of

right US code 18 245 federal protected activities seems to apply in this case. The definition of harassment and stalking in SC title 16 section 1700. The right to a restraining order title 16 section 1750 and Interstate stalking US code title 18 section 2261 a

8. The most important issues are that no one should lose their life without a trial or due process of law without a fair and impartial jury. There are very facts no one should lose their property without due process of law John Adams stated "that a person's property or liberty should not be infringed there should be rights by the government". I think no one should lose their life of working 40 years of legal employment and being a resident or living in apartments the same amount of time without a trial to examine or cross examine witnesses and question truth facts, bring out facts for both parties including the defense. There should be a speedy trial with an impartial jury The truth should be questioned and examined not just one sided and persons whom are supposed to be innocent in the world but are not. The defendant or the truthful should be given a fair trial but may never have been given a chance to examine the facts the truth or to prove that they are the same innocence, the same decent innocent nice and decent person who are diversity as the good persons they always have been. The same good, decent persons they been in the past, current and they will continue to try to be into the future

9. The other important issue is no one should lose 10,000 worth stuff in apartment legally obtained where legally live or a legally financed vehicle or money down payment or the money or payments vehicle or insurance and insurance payments without a trial or consideration of innocence.

10. The main issue to lose a job for 2 years 8 months and later complete loss for getting employment or ability to move in apartment without due process of law or a trial or loss of finances or income

11. The main issue is not to lose an apartment or be removed after 5 years in apartment without a trial or further no one letting the person move to an apartment denying a US citizen right without a trial or examine the facts. The defendant should not be assumed a liar and others completely assumed innocent persons in the world without first questions of truth or their truth or what they may be or some other motives.

12. The main issue is no one should lose their reputation or character, or standard or be humiliated in the community or humiliated to persons all around including persons they grew up with or feeling or below others or completely embarrassed being treated immature when they been mature with at least a chance of a speedy fair trial or due process and examine the

harassment intimidation as seems to be same repeated patterns by same persons. There should be investigations into some these persons slavery, and pimping acts, actions or whom they really are or what they represent or corruption

The employees this should be protected at least by fair equal protection of law a trial by impartial jury. They should award compensation and what was a loss or financial loses if a defendant wins a trial. I again ask the right to retire after all years I worked as an employee

I, Ken Moorehead appeal this action for not giving me due process of law and still request a trial by an impartial jury without being held on 03/27/2026 Friday afternoon in Myrtle Beach, SC. The appeal now as denied by SC Court of Appeals I am now appealing to SC Supreme Court on 03/27/2026. I appeal on some law issues or rights for my life as a natural born United States citizen living in United States of America currently in Myrtle Beach, SC 03/27/2026. I request some mercy in my own country as good loyal system and to be protected from older persons even if known to me from their unfairness, gang stuff in one group like gang from their interstate stalking, harassment, bullying and complete unfairness and ask for some unfairness with diversity I have shown with diversity to me. I ask for the US protection laws, the US constitution, treaties the United States laws be allowed for me in the UNITED STATES OF AMERICA be allowed in the USA where I was born, lived, resided my whole life as a loyal USA good citizen.
