Dear Mr. Williams:

The Court received the following motions from you:

- “Motion pursuant to Rule 240, SCACR, to proceed without a transcript” filed March 11, 2026;
- “Omnibus Motion for Summary Reversal, Disqualification of Counsel, and ODC Referral” filed March 16, 2026;
- “Motion to Strike Respondent’s Return to Motion” filed March 19, 2026; and
- “Consolidated Motion for Sanctions against Respondents and Counsel for Systemic Extrinsic Fraud and Unwaivable Conflict of Interest” filed March 20, 2026.

Upon reviewing the above-mentioned motions, the following deficiencies have been noted under the South Carolina Appellate Court Rules (SCACR), and each deficiency must be corrected within ten (10) days of the date of this letter or this matter will be dismissed and this Court will not consider the motions:

- There is no accompanying proof of service in compliance with the SCACR. Your proof of service should be substantially in the format shown by Form 7 in Appendix C to part II of the SCACR pursuant to Rule 262(b).

Specifically, pursuant to Rule 262(c)(3), SCACR, and *Re: Methods of Electronic Filing & Service Under Rule 262 of the South Carolina Appellate Court Rules*, S.C. Sup. Ct. Order dated May 6, 2022, only a lawyer admitted to practice law in South Carolina may serve a document on another lawyer admitted to practice law in South Carolina using the lawyer's primary e-mail address in AIS. You must provide a proof of service showing that you served each of the above-referenced motions on Respondent by US mail.

- The required filing fees have not been submitted for the notice of appeal or any of the motions you filed. The correct filing fee is \$250 for the notice of appeal and \$50 for each motion. *See* Rules 203 and 240, SCACR. If you do not pay the \$250 notice of appeal filing fee, this appeal will be dismissed. If you do not pay the \$50 filing fee for *each* of the four above-referenced motions (totaling \$200), this Court will not consider the motions.

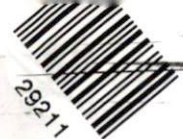
