MOTION FOR AN EXTENSION OF TIME
TO FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Jose Reyes Reyes respectfully requests an extension of thirty (30) days from April 6, 2026, until May 6, 2026 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Jose Reyes Reyes respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the Anders Brief of Appellant and Record on Appeal in the case of The State v. Derrick Edward Gathers with the Court of Appeals on March 11, 2026. Counsel filed the Record on Appeal and Final Brief of Appellant in the case of The State v. Mustafa A. Salaam with the Court of Appeals on March 9, 2026. Counsel filed the Petition for Rehearing in the case of Erick E. Wells v. The State with the Court of Appeals on March 5, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Devonte T. Major v. The State with the Supreme Court on February 20, 2026. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Mark S. Wingo v. The State with the Supreme Court on February 13, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and the Appendix in the case of James Lee McCoy, II v. The State with the Supreme Court on January 23, 2026..

4. Counsel makes this request in good faith and not for purpose of delay.


