Good afternoon Mr. Norville.

We do have a backup file of the recording for this hearing; it is stored separately in case one gets corrupted. The file that we have stored is also muted for approximately 33 minutes. In your message to me this morning, you stated that your office was not informed until this moment that there was an issue with audio missing. I have attached an email from Legal Eagle to SCCID where you were informed that a portion of the recording for June 12, 2024, was muted for approximately 35 minutes. That email was sent to SCCID on October 20, 2025, and reiterated in another email sent on October 29, 2025.

This recording was captured via WebEx and therefore we do not have exact time stamps since WebEx does not time stamp their video/audio files. WebEx also does not have a way for the court reporter to enter notes into their system to show these time stamps. The occasions that you mentioned in your email below are noted in the transcript by parenthetical, the time stamps were not available.

Thirdly, the first page of the transcript does list the date of the multi-day trial. Again, there is not a time stamp which I explain in the above paragraph.

We were not informed until this moment that the tape does not exist. I understand Chapter XIII, Section C requires the court reporter to retain the primary and back-up tapes of transcribed proceedings for at least one year after the original transcript is sent to the requesting party. Has the back-up tape been looked into at this juncture?

Regarding time stamps of jury movements, Chapter XV, Section M of the attached South Carolina Court Reporter Manual, page 34: "The court reporter is required to enter the following in parenthetical form: the times the jury enters and exits the courtroom for any reason, begins deliberations, and returns the verdict. (See Appendix 3, Exhibit 12)." <https://www.sccourts.org/media/1p2hbkmw/courtreportermanual.pdf>

Additionally, if you look to the first page of the multi-day trial transcript, you will notice that it does not note the time or the date of the proceedings. Multi-day trial transcripts should clearly indicate the time and date of proceedings each time the Court is called to order.
