

Defendant was incarcerated 64 days on the first Aiken County Adult Drug Court bench warrant and 78 days on the second Aiken County Adult Drug Court bench warrant. Additionally, Judge Martha M. Rivers amended Defendant's credit for time served on Indictments 2025-GS-02-00214 and 2025-GS-02-00215 to include the additional 142 days credit for time served as of April 7, 2026.

ORDER

THEREFORE IT IS ORDERED that Defendant's Credit for Time Served for indictments 2025-GS-02-00214 and 2025-GS-02-00215 be amended to reflect that Defendant is entitled to receive credit for time served in the amount of 378 days as of April 7, 2026.

previously understood so ADC allowed Defendant another opportunity to enter the Oxford House. Defendant entered the Oxford House and was terminated from that program shortly after his acceptance. On November 20, 2025, Defendant admitted to using narcotics during ADC and was placed on zero tolerance. Following this hearing Defendant became very ill and was excused from multiple program requirements through the end of the year 2025.

On January 8, 2026, Defendant did not show to court and was not excused. A bench warrant was issued for non-compliance for Defendant having not called in, not gone to group counseling, and not attending court. Defendant remained non-compliant in all aspects of ADC until he was picked up on the bench warrant when he was arrested on new charges for Shoplifting, and Violation of a City Ordinance on January 20, 2026.

Defendant's second termination hearing was held before Judge Tracey Carroll on February 26, 2026. Present at the hearing were the Defendant, his public defender, Derek M. Bush, the State represented by Assistant Solicitor Michelle Hajher, and the ADC team. At the conclusion of the hearing Judge Carroll terminated Defendant from ADC due to the totality of Defendant's non-compliance with program requirements as outlined above. The Defendant having been referred to Drug Court previously, and having now been dismissed from Drug Court, the imposition of the Order of Dismissal shall transfer the Defendant's case back to the Second Circuit General Sessions Court for disposition.

IT IS THEREFORE ORDERED that Damian Vertez Burley is hereby dismissed from the Aiken County Adult Drug Court and the above-referenced matter transferred back to the Second Circuit General Sessions Court.
