Pro-Se Defendant Terrell Herbert Sr. files this Notice to Appeal his convictions of 1st Degree Harassment on 3-18-26. The trial court errored in denying the Defendant's Judicial Enforcement of his Speedy trial right that was filed on August, 18th, 2025. The trial court set a date for trial on December, 15, 2025 by Judge Nettles and it was continued by no falt of the Defendant, Solicitor James White expressed that the trial was delayed because Judge Nettles didn't have enough Juniors on that date and chose to preside over two others trials. Even after the case was continued on December, 15th this case was still delayed for another 3 months setting the trial date for March, 18th, 2026. Durning that the trial court also errored in denying the Defendant's motion to dismiss for a Due Process Violation.

The trial court also erred by misleading the jury by not giving them the opportunity to hear the statute for S.C. Code 16-3-1700B even though an incident report that was submitted by the solicitor into discovery has 2nd Degree Harassment as the charge on it by Investigator Angel Clark from F.C.S.O. During my cross examination of the state's witness Ms. Clark, the defense addressed that issue, and had her read the charge and the report for the record. When the defense asked her for the statute of 2nd Degree Harassment Solicitor White objected and Judge Seals sustained it, even though this was discovery that was submitted by the state, and being addressed by the defense. Investigator Clark even stated on record that she never seen or was made aware of any threats being made to Chavez McCall even though he made a statement that the defense did. For these reasons The Defense asks this appeal be granted and his convictions overturned.
