MOTION TO CONSOLIDATE APPEALS

Appellants Otha M. Delaney, Octavia D. Watson, Alicia S. Alston, and Paul D. McGuiggan, Jr., individually and on behalf of all others similarly situated as Co-Class Representatives (“Appellants”), hereby move pursuant to Rule 214, SCACR, to consolidate appeals 2026-000244 and 2026-000866.¹ Appellants’ Motion is due to be granted for several reasons.

First, these two appeals involve the same order. Rule 214 expressly permits the consolidation of appeals when “there is more than one appeal from the same order, judgment, decision, or decree.” Here, both appeals involve the circuit court’s February 26, 2026, and January 22, 2026 orders. Moreover, the two appeals involve the same factual and procedural records.

Second, the parties to the two appeals are the same. While Respondent's appeal (2026-000244) listed only Otha M. Delaney as the respondent, Appellants Watson, Alston, and McGuiggan are Co-Class Representatives by the circuit court's January 22, 2026 order and consequently appellants in appeal number 2026-000244. Appellants and Co-Class Representatives are, in any event, members of the certified class which is the respondent in appeal number 2026-000244.

Third, consolidation will prevent duplicative briefing and conserve judicial resources by allowing the Court to address the issues in a single proceeding. The two appeals will require the parties and the Court to manage two separate filing deadlines and potentially two separate scheduling tracks. Consolidation will create one streamlined briefing and filing schedule and may result in only one oral argument. Additionally, consolidation will avoid inconsistent results.

Fourth and finally, consolidation will not prejudice any party or delay resolution because the appeals are at the same procedural stages and no party will be deprived of the opportunity to fully brief the issues. In fact, in this almost fifteen-year-old case, consolidation will promote faster resolution to these interlocutory appeals so the underlying lawsuit may proceed to conclusion.


