MOTION FOR AN EXTENSION OF TIME  
TO FILE THE PETITION FOR WRIT OF CERTIORARI

Counsel for Sinatra Hunter respectfully requests an extension of thirty (30) days from April 16, 2026, until May 18, 2026 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Justin Cole Carroll in the Court of Appeals on April 8, 2026. Counsel filed the Petition for Rehearing in the case of The State v. Jason Barry Bell with the Court of Appeals on April 1, 2026. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Jaquese Kavon Hyatt v. The State with the Supreme Court on March 17, 2026. Counsel filed the Initial Brief of Appellant in the case of The State v. Darryl Jerome Washington with the Court of Appeals on March 9, 2026. Counsel filed the Petition for Writ of Certiorari and accompanying Appendix in the case of Pamela Michelle Tackett v. The State with the Supreme Court on March 2, 2026. Counsel spoke at the Criminal Practice CLE in Columbia on February 27, 2026. Counsel filed the Brief of Petitioner in the case of Jason Ervin Black v. The State with the Supreme Court on February 26, 2026. Counsel had an oral argument in The State v. Jason Barry Bell in the Court of Appeals on February 12, 2026. Counsel filed the Petition for Rehearing in the case of The State v. William L. McKinney with the Court of Appeals on February 5, 2026. Counsel filed the Petition for Rehearing in the case of The State v. Phillip Ryan Lawson with the Court of Appeals on February 5, 2026.

4. Counsel makes this request in good faith and not for purpose of delay.


