We apologize for inundating the Court with correspondence after the briefing has been completed, and we do not wish to further complicate the process. However, we felt a clarification was warranted based on correspondence recently submitted by the South Carolina Department of Employment Workforce ("the Agency"), dated December 2, 2013. The Agency has already raised the *Bone v. U.S. Foods Service*, 404 S.C. 67, 744 S.E. 2d 552 (2013) decision by letter dated July 8, 2013, and Nucor submitted its response on July 13, 2013, subsequent to which, the Court of Appeals notified the parties that oral argument had been scheduled for October 8, 2013. Following that, the case was certified to the South Carolina Supreme Court, and an oral argument is currently scheduled for 10:00 a.m. on January 7, 2014. Thus, the Agency's correspondence is duplicative and does not raise any new controlling authority warranting dismissal of Nucor's appeal.
