Thank you, Natalie, for your email and transcription attachment first attempt. I journeyed out of state since our last correspondence and had limited-to-no internet access, so am just receiving this for review now.

There seem to be a significant number of errors in the content and several omissions ("inaudible") in words spoken by the parties on this transcription. Because this is critical to the truth of my case being properly relayed in The Court Of Appeals, I will ask you to:

**1. revisit the audio for corrections** and perhaps listen more intently/repetitively to the words that you may have missed on your first pass. With all due respect, I am aware that I paid you for a 7-day turnaround -- and you stated that your workload would prohibit you from doing it any sooner. To this, I agreed (partially b/c I did not desire to rush you and partially b/c I knew I'd be out of contact for at least 7 days). Yet, you apparently returned this transcription by email in less than 2 days.

**2. share w/ me the audio** associated w/ this transcription; I am eager and willing to fill in the "inaudible" words and other content that I remember was spoken, but doesn't appear in the transcription (perhaps it was lost b/c there were a few instances when both I and the judge were speaking at the same time.)

Every word is critical to the true and correct data being presented. I know you know that already...and I greatly appreciate your time and efforts!
