APPELLANT’S RETURN TO MOTION TO CONSOLIDATE¹

First Financial of Charleston, Inc. (“FFC”), by and through its undersigned counsel, files this Return to Otha Delaney’s, Octavia Watson’s, Alicia Alston’s, and Paul McGuiggan’s (collectively “Delaney”) Motion to Consolidate Appellate Case No. 2026-000866 (“Delaney 4”) and Appellate Case No. 2026-000244 (“Delaney 3”).

FFC does not object to the consolidation of the Appellate Case No. 2026-000244 and Appellate Case No. 2026-000866. FFC only requests the Court clarify the briefing schedule following the consolidation of the appeals and wants to bring to the Court’s attention that Delaney’s counsel has consented to a 30-day extension for FFC’s deadline to file and serve its

initial brief and designation of matter in Appellate Case No. 2026-000244. FFC will file a formal motion for extension of time should this Court so require. However, FFC believes that both Delaney's motion to consolidate and the extension of time for FFC to file and serve its initial brief and designation of matter in Delaney 3 can be addressed simultaneously within the motion to consolidate, and requests the Court use this opportunity to set the briefing schedule following consolidation in line with the agreement among FFC and Delaney.²
