

Corey Arthur White appeals his conviction and sentence in this case in addition to the General Sessions Court's denial of his motion for a new trial or in the alternative resentencing.

On March 12, 2026, the Defendant was found guilty of Murder and Possession of a Weapon During a Violent Crime. Accordingly, the Honorable Jennifer B. McCoy sentenced Corey Arthur White to 35 years on Murder and to 5 years on the Possession of a Weapon During a Violent Crime.

On March 20, 2026, Corey Arthur White filed a motion for a new trial or in the alternative resentencing within 10 days of his conviction date, per Rule 29 of the South Carolina Rules of Criminal Procedure, and on March 31, 2026, the State filed a response to Corey Arthur White's motion.

On April 17, 2026, the General Sessions Court issued an order denying Corey Arthur White's motion for a new trial or in the alternative resentencing with written notice of the order received by Corey Arthur White's attorney on April 20, 2026.

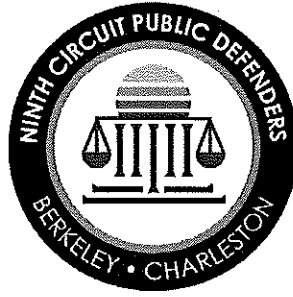

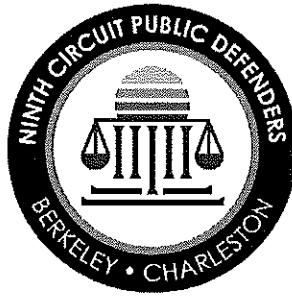
