The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on May 23, 2022 at approximately 11:45 AM, while at 5020 Rivers Avenue, Room 228, which is located in the City of North Charleston, County of Charleston, State of South Carolina, the defendant, one Corey Arthur White, did, knowingly, unlawfully, and with malice aforethought, commit the offense of MURDER in violation of 16-3-10 of the South Carolina Code of Laws 1976 as amended. In that the defendant did shoot and kill the victim, [REDACTED] while armed with a firearm.

Facts to establish the aforesaid are that on May 23, 2022 at approximately 1:45 PM officers with the North Charleston Police Department were dispatched to [REDACTED] in reference to an employee finding a deceased male inside the room. Patrol officers arrived and discovered the victim suffering from several apparent gunshot wounds. Several spent 9mm shell casings were located near the victim's body. Detectives reviewed surveillance footage from the business and discovered two males enter the room at approximately 11:44 AM. There appeared to be some type of disturbance followed by several individuals leaving the room. A male wearing a blue shirt leaves first and appears to place something in his wasteband prior to departing the scene. One of the males that left the room was later located on the other side of the business. That male (witness) advised that he was inside room 228 when the shooting occurred. The witness stated that a male that he knows as "Ox" entered the room and got into a verbal altercation with the victim. He stated that during the altercation "Ox" pulled and pistol and shot the victim several times. The witness knew the suspect as "Ox" and knew that his last name was White. The witness later identified the defendant as "Ox" and the person that shot and killed the victim. That identification was made via a single photo identification.

All based on the investigation of Detective Pritchard and statements provided by the witness who is witness to prove the same. All this done against the law, peace and dignity of the City of North Charleston and the State of South Carolina.

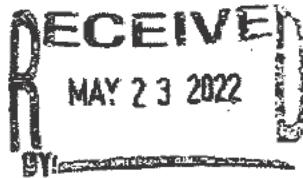
