Please be advise that in lieu of a formal motion that you accept this letter as a Motion for a Writ of Mandamus to ORDER the court reporter, in which I do not have a name for to respond to my request to agree regarding payment for the transcript in writing; to provide me a SCCA Form 800, and to provide a date the transcript will be available, because as of this date I have not received a response from the Court Administration nor the court reporter during the 12/18/24 hearing.

I have exhausted all means in obtaining the transcript, and it is beyond my control for the court administration or the court reporter to respond to my request. As such, at this current time, I am respectfully asking the court to intervene and order the court reporter to perform its ministerial duty, because I have tried since January 2025 to find out the name of the court reporter to make arrangements for the transcript, only for one of the attorneys for the Respondent state that they had made arrangements for the transcript for the court.

I have submitted another letter as a follow-up (4/17/26) for a response, but the 30 days the appeal in abeyance is 13 days away, and I have not received anything from the court administration. As such, I am requesting for additional days for the appeal to be held in abeyance until this matter is resolved with the court administration.
